# Background

The CJC was created by statute in 1984 and was united with the SAC in 2011. The Board of Parole was added in July 2014. This fiscal year Delaware Anti-Trafficking Action Council was added.

The Council consists of 29 members, including representatives from the Governor's cabinet, the judiciary, state and local police departments, state and local and government agencies, and members of the community.

#### FY 2024 budget consists of 25 general fund FTE's:

- 8 CJC positions
- 7 SAC positions
- 5 DVCC positions
- 2 Board of Parole
- 3 Delaware Anti-Trafficking Action Council positions


# FY2024 General Fund Budget

### Videophone, Law Enforcement Reimbursement Program and Domestic Violence Fund

Videophone revenue is imposed and collected by the courts for crimes or offenses as defined in Title 11 § 233.

FY23 Actual Revenue \$125,519

#### Local Law Enforcement Education Reimbursement Fund

FY23 \$150,000 -During FY23 the program supported 48 law enforcement officers. Since the inception of the program CJC has provided more than 1,100 reimbursements to nearly 400 officers totaling \$1.5 million

#### Public Attorney Student Loan Repayment Assistance Program

FY23 \$500,000 During FY23 the program supported 48 attorneys.

## Domestic Violence Fund revenue is composed of \$15 from each fee for a certified marriage license or certificate copy as defined in Title 16 § 3132(b)

# Highlights and Current Activities

In FY2024, CJC awarded funding for more than <u>200</u> projects in excess of <u>\$17.5</u> million federal dollars. The CJC also continued to administer over <u>\$10.5</u> million in grants awarded in previous years, bringing the total of federal funds to over <u>\$27.5</u> million.

Through the support of OMB, CJC E-grants was implemented in July 2014. The CJC continues user training and maintenance of the system. As of today, over \$135.6 million has been administered in this system.

Our Only request this year was for \$200,000 to replace E-grants with Smart Simple – the same GMS that has just been implemented by the DE State Legislature



### **Statistical Analysis Center**

#### **Mission**

#### • 11 § 8902

The Statistical Analysis Center shall provide the State with a professional capability for objective, interpretive analysis of data relating to crime and criminal justice issues in order to improve the effectiveness of policy-making, program development, planning and reporting.

#### **Statutory Obligations**

#### • 11 § 2104(e)(2)

The SAC shall provide the court with a report of rates of re-arrest and failure to appear as required by persons [defendants] released by the court.

#### • 11 § 2107(g)

In addition to the information required in the annual report established in § 2114(i) of this title, the Criminal Justice Council shall include information of the following in the aggregate and disaggregated by race, gender, and zip code of:

(1) Rates of defendants' eligibility under subsection (c) of this section.

(2) Rates of initial detention.

(3) Rates of detention throughout the pretrial period.

(4) Average length of stay from arrest to adjudication.



(9) Conduct research and provide analyses as required to determine the impact proposed policy changes may have on the criminal justice system;

(10) Submit annually to the Governor, Chief Justice, President Pro Tem of the Senate, and the Speaker of the House a report examining 1-year, 2-year, and 3-year rates of re-arrest, reconviction, and recommitment of released offender cohorts.


#### • 14 § 9006A(b)

By October 1 of each year, the Statistical Analysis Center shall submit to the Department of Justice a report on the outcome or status of complaints of violations of §§ 767-773 of Title 11 where the alleged victim or the alleged perpetrator, or both, is a student of an academic institution and whether the alleged offense occurred on campus at an academic institution. The report shall cover the previous calendar year.




#### Number of Bills SAC Analyzed by Type and General Assembly



The DVCC was established in 1993.

The agency was established with the Executive Director and Project Coordinator (2 staff). FY00 – added a dedicated Senior Secretary and Public Education Specialist. FY06 – added a Project Coordinator position.

#### July 1, 2023 – June 30, 2024

- 4 Educational Sessions and 15 training sessions
- A total of 474 people trained since July 2023. Coming up: 1 full-day Law Enforcement & MDT webinar on Strangulation 2/22, 1 full-day Treatment Conference on 3/6, 1 training on Stalking 3/26, and more in the works for May/June.
- 126 advocates trained
- 29 Law Enforcement Officers or Representatives trained
- 225 members of the general public reached
- 22 Teens have been through a DVCC workshop

# **DVCC** Committees

#### **Family Justice Center Steering Committee** (ad hoc, Established 2021) + 6 Work Groups:

- Feasibility Study being conducted by Tevebaugh Architecture is nearing its conclusion
- Visioning Sessions with partners in each county were conducted in June 2023
- Site visits to FJCs in Brooklyn, Manhattan, Fort Worth, New Orleans, and 3 in California

#### Animal Abuse & Domestic Violence Link Committee (Established 2022):

• Moved 3 bills to passage in 2023: inclusion of "animal abuse" in the PFA definitions, requiring animals to be addressed in divorce, & requiring reporting of animal abuse by DFS when investigating child abuse and reporting of child abuse by OWA when investigating animal abuse.

• Updated the Guidelines for Responding to Teen Dating & Sexual Violence in Delaware Schools

#### **Criminal Justice Committee**

- Arizona State University study to develop a validated DV Risk Assessment Tool for use in the Pre-Trial Settings is moving forward.
- Created a Strangulation Protocol that was approved by DVCC in Sept & by Police Chiefs' Council in November

#### **Elderly and Domestic Violence Committee**

• Discussing a new name for this committee & working on World Elder Abuse Day event



## Fatal Incident Review Team

The Fatal Incident Review Team (FIRT) was established in 1996 under 13 <u>Del. C.</u> **§** 2105



Full report may be found on: <u>dvcc.delaware.gov</u> FIRT consists of 14 members defined in statute.

#### 2023 FIRT Report included 5 recommendations.

**146** domestic violence fatal incident reviews have been conducted by FIRT since it's inception.

Those included **183 deaths** and **6 near deaths**.

#### FY2024

The Social Service Senior Administrator was hired last January and the team held 3 reviews in 2023.

The team has had new members approved and will be reviewing procedures and national best practices. FIRT will also focus on comprehensive tracking of near deaths to ensure it is as effective as it can be. <sup>36</sup>
