SENATE BILL NO. 121

AN ACT TO AMEND TITLE 15 OF THE DELAWARE CODE RELATING TO ELECTIONS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Two-thirds of all members elected to each house thereof concurring therein):

1 Section 1. Amend § 101, Title 15 of the Delaware Code by making deletions as shown by strike through and
2 insertions as shown by underline as follows:

3 § 101. Definitions.

4 As used in this title:

5 (9) "Election officers" means the inspector of election, the 2 judges of election and the clerks of election who
6 are appointed for each election district under ~~§ 4701~~ § 4702 of this title.

7 Section 2. Amend § 2049, Title 15 of the Delaware Code by making deletions as shown by strike through and
8 insertions as shown by underline as follows:

9 § 2049. Change of party designation; procedure.

10 (a) Any duly registered voter may apply to change that registered voter's political affiliation by completing and
11 submitting a voter registration application to the Department except in the year of a general election during the period from
12 the last Saturday in May through the day of the primary election. The application shall be upon a form provided by the
13 Commissioner and shall be signed by the registrant and returned by mail or delivered to the ~~office of the Department.~~
14 Department. An appropriately addressed envelope shall be supplied by the Department for return of the executed
15 application. Upon receipt of the executed application, the Department shall cause the signature to be compared with the
16 original registration record of such applicant, and if such signature appears to be the same, such change of affiliation shall
17 be made ~~on the original and duplicate~~ in the voter registration records and the applicant shall be immediately ~~notified by~~
18 ~~mail of the change so made.~~ notified. If the Department is not satisfied as to the signature on the application, the applicant
19 shall be notified by mail to appear at any office of the Department to answer under oath such questions as may be deemed
20 necessary. ~~If the applicant fails to appear as notified, no such change of affiliation shall be made. If the application is made~~
21 ~~to the registration officers, they shall forward the completed application to the Department at the same time as they forward~~

22 other registration records at the close of registration, and the Department shall cause appropriate notations thereof to be
23 made upon the applicant's registration record in the applicable County Master File and the applicant's record in the Election
24 System data base.

25 Section 3. Amend § 3002, Title 15 of the Delaware Code by making deletions as shown by strike through and
26 insertions as shown by underline as follows:

27 § 3002. Unaffiliated candidates.

28 (a) No person shall qualify to appear on the general election ballot of this State as a candidate unaffiliated with a
29 political party unless such person fulfills the requirements of this chapter and is so certified by the ~~Department of Elections~~
30 State Election Commissioner, if a statewide candidate, or the Department of Elections, office for the county where the
31 candidate resides, if not a statewide candidate.

32 (b) No individual shall be listed as an unaffiliated candidate on any general election ballot unless such individual
33 shall have ~~filed,~~ filed on forms promulgated by the State Election Commissioner, on or before the close of the official
34 business day on September 1 of the general election year, a sworn declaration with the State Election Commissioner, if a
35 statewide candidate, or the ~~Department,~~ Department office for the county where the candidate resides, if a nonstatewide
36 candidate, stating that the ~~nonstatewide candidate is an unaffiliated candidate and~~ candidate has not been affiliated with
37 any political party for at least 3 months prior to the filing of the declaration, as required by this ~~title,~~ title. By September 1
38 of a general election year, the candidate and shall have filed shall file nominating petitions, as prescribed in this chapter,
39 ~~and~~ signed by not less than ~~4 percent~~ 1% of the total number of voters registered, as of December 31 of the year
40 immediately preceding the general election year in the State, or if a nonstatewide candidate, of those voters eligible
41 registered to vote for that office which such individual seeks.

42 Section 4. Amend § 3106, Title 15 of the Delaware Code by making deletions as shown by strike through and
43 insertions as shown by underline as follows:

44 § 3106. Filing of candidacy for nomination at a primary election; withdrawal.

45 (a) Any person desiring to be a candidate shall give notice in the following manner:

46 (2) Candidates for all other offices:

47 a. All candidates for county or countywide office, members of the General ~~Assembly and/or~~ Assembly, or
48 municipal office for any municipality holding its election at the time of the general election shall notify the county
49 chair, or the county chair's designee, in ~~writing (or~~ writing, or the city chair, or the city chair's designee, if
50 applicable for municipal ~~and candidates)~~ candidates, of their respective political party in their county of residence on

51 forms prescribed by the State Election Commissioner on or before the deadline ~~set forth in~~ under § 3101(1) of this
52 title.

53 b. At the time of giving notice as required ~~above~~, under paragraph (a)(2) of this section, each candidate
54 shall tender the required filing fee, if any, by giving a check to the ~~Department~~, Department office for the county
55 in which the candidate resides, payable to the county committee of the candidate's political ~~party (or party, or city~~
56 ~~committee, if applicable for municipal candidates)~~, candidates, together with a copy of the notice given to the
57 party chair. At such time, the Department office shall receipt a ~~third~~ copy of the ~~notice, to be provided~~ notice to the
58 candidate.

59 (b) If any of the filing fees mentioned in subsection (a) of this section are not required, each candidate shall still
60 give notice to ~~the election agency having jurisdiction~~, the Department office for the county in which the candidate resides,
61 as specified in paragraphs (a)(1) and (2) of this section, and ~~shall receive a receipted copy of the prescribed form. the~~
62 Department office shall receipt a copy of the notice to the candidate.

63 (c) Any candidate who has filed for nomination as ~~required above~~ under subsection (a) or (b) of this section may
64 withdraw ~~said the~~ filing by notifying the ~~respective elections agency with whom that~~ Department office with which the
65 candidate filed on forms prescribed by the State Election Commissioner on or before the deadline ~~set forth in~~ under §
66 3101(2) of this title. ~~The elections agency having jurisdiction~~ The Department office for the county in which the candidate
67 resides shall promptly notify the same political party chair who received the original notice of filing. The political party
68 shall return the candidate's filing fee of the candidate so withdrawing shall be returned to the candidate. fee. In the event If
69 a candidate withdraws after the deadline ~~set forth in~~ under § 3101(2) of this title, ~~such the~~ candidate shall forfeit the filing
70 fee to the political party. ~~In cases where no filing fee was required, any candidate withdrawing after the deadline shall~~
71 ~~submit to the respective elections agency a check payable to the Treasurer of the State in the amount of \$50.~~

72 Section 5. Amend § 3124, Title 15 of the Delaware Code by making deletions as shown by strike through and
73 insertions as shown by underline as follows:

74 § 3124. Ballots for voting ~~machines~~: devices.

75 (a) The Department shall cause to be ~~printed~~ created the ballots to be used in any primary ~~election and shall cause~~
76 ~~the same to be placed in voting machines for the proper district prior to the delivery of the voting machines. election.~~

77 (b) The names of all candidates for nomination for the same office ~~shall~~ must be placed under the title of ~~such the~~
78 office, the surname of candidates to be placed in alphabetical order, and ~~shall~~ may not be separated one from another by any
79 other matter.

80 Section 6. Amend § 3125, Title 15 of the Delaware Code by making deletions as shown by strike through and
81 insertions as shown by underline as follows:

82 § 3125. Department to furnish voting ~~machines,~~ devices, flags, ~~supplies~~ supplies, and instructions for polling
83 places.

84 For each polling place, the Department shall furnish all of the following:

85 (1) A flag or poster of suitable size for lettering thereon in at least 3-inch letters with the words POLLING
86 ~~PLACE;~~ PLACE.

87 (2) A flag of the United States of America no smaller in size than the polling place flag ~~above described in~~
88 under paragraph (1) of this section; section.

89 (3) Poll list, ~~stationery~~ stationary, and other such supplies customary and necessary for the use of the officers
90 conducting such primary ~~election;~~ election.

91 (4) Written instructions and excerpts from those parts of this title as the Department ~~shall deem~~ deems
92 necessary and appropriate to assist the election officers in the proper performance of ~~their duties;~~ the officers' duties.

93 (5) A proper number of voting ~~machines-devices~~ of the type used in general elections, which ~~machines shall~~
94 devices must be duly inspected, ~~prepared~~ prepared, and certified ~~in the same manner as provided for under Chapter 50~~
95 Chapter 50A of this title for general elections.

96 Section 7. Amend § 3126, Title 15 of the Delaware Code by making deletions as shown by strike through and
97 insertions as shown by underline as follows:

98 § 3126. Voting to be by voting ~~machines.~~ devices.

99 In every primary election district in which a primary election is to be held under this chapter, voting ~~machines~~
100 devices of the type used in general elections, as provided for in ~~Chapter 50 or~~ Chapter 50A of this title, ~~shall~~ must be used
101 to record the votes, and the manner of voting ~~shall~~ must be the same as that set forth in Chapter 49 of this title.

102 Section 8. Amend § 3172, Title 15 of the Delaware Code by making deletions as shown by strike through and
103 insertions as shown by underline as follows:

104 § 3172. Calculation of votes; ties.

105 (a) The Department shall forthwith calculate the total number of votes cast for each candidate in any contest and
106 certify the candidate or candidates receiving the highest number of votes. ~~In cases of statewide contests, the Department~~
107 ~~shall report the results to the State Election Commissioner.~~

108 (e) ~~In the event that~~ If the number of votes separating a candidate and the closest opposing candidate in a primary
109 election is less than ~~1,000~~ (in 1,000 votes, in the case of a statewide ~~contest)~~ votes-contest, or 1/2 of ~~1 percent~~ (in the case

110 ~~of any contest~~ 1% of all votes cast for the 2 candidates, in the case of any other contest, whichever is less; less, the
111 Department shall recount the ~~absentee~~ ballots cast in that election at State expense as part of the canvass of the vote.

112 Section 9. Amend § 3301, Title 15 of the Delaware Code by making deletions as shown by strike through and
113 insertions as shown by underline as follows:

114 § 3301. Certificates of nomination.

115 (d) The presiding officer and secretary of the county committee of each political party eligible to place candidates
116 on the ballot shall submit a certificate of nomination for candidates for the General ~~Assembly, Assembly and~~ county and
117 municipal offices to the ~~Department, Department~~ office for the county in which the candidate resides, as follows:

118 (1) For any office for which no candidate has filed in accordance with § 3101 of this ~~title, or title.~~

119 (2) For any office for which candidates are selected by the state nominating convention of a minor political
120 party.

121 (e) ~~In the case of~~ For minor political parties not required to select candidates ~~pursuant to~~ under Chapter 31 of this
122 title, each party shall select ~~their~~ its candidates at the party's state or county nominating convention held on or before
123 August 1 in the year of a general election and shall file the certificates of nomination of the selected candidates within 10
124 business days of the nominating convention.

125 (h) The State Election Commissioner shall verify that the nominations of candidates submitted to the State
126 Election Commissioner and the eligibility of each political party to make such nominations conform to the requirements ~~set~~
127 ~~forth in~~ under this title. The Department offices shall do the same concerning certificates of nomination submitted to ~~it, the~~
128 offices.

129 (i) The State Election Commissioner shall forthwith send a copy of each certificate of nomination submitted to the
130 Commissioner to the ~~Department, Department~~ offices. The Department offices shall forthwith send a copy of each
131 certificate of nomination submitted to ~~it~~ the offices to the State Election Commissioner.

132 Section 10. Amend § 3303, Title 15 of the Delaware Code by making deletions as shown by strike through and
133 insertions as shown by underline as follows:

134 § 3303. Time of filing certificates.

135 Certificates of nomination for statewide office to be filed with the State Election ~~Commissioner or the Department,~~
136 Commissioner, and certificates of nominations for nonstatewide offices to be filed with the Department office for the
137 county where the nominee resides, as the case may be, ~~shall~~ must be filed before the close of the official business day on or
138 before September 1 of the year of any general election, and if September 1 is a Sunday or legal holiday, then on the next
139 official business day. Certificates of nomination ~~shall~~ must be on the form specified by the State Election Commissioner.

140 However, when there is a national nominating convention, the nominees from ~~said the~~ national nominating convention ~~shall~~
141 must be named on a certificate of nomination to be filed before 12:00 noon on the earlier ~~of~~ of the following:

142 (1) The Tuesday following ~~said the~~ national nominating ~~convention; or, convention.~~

143 (2) September 15 of ~~said the~~ election year.

144 Section 11. Amend § 3402, Title 15 of the Delaware Code by making deletions as shown by strike through and
145 insertions as shown by underline as follows:

146 § 3402. Write-in candidates for a general election.

147 (c) A person shall declare ~~himself or herself~~ as a write-in candidate for an office by filing a Write-in Candidate
148 Declaration with the State Election Commissioner for a statewide office or ~~to the Department of Elections~~ office for the
149 county in which the election is to be held for General Assembly, ~~county~~ county, or City of Wilmington offices no later than
150 4:30 p.m. on September ~~30~~ 20 in the year of a general election. If September ~~30~~ 20 is a Saturday, ~~Sunday~~ Sunday, or
151 holiday, the declaration ~~shall~~ must be filed no later than 4:30 p.m. on the next day that is not a Saturday, ~~Sunday~~ Sunday, or
152 holiday. If the boundary of a General Assembly office includes more than 1 county, the person shall file that person's
153 Write-in Candidate Declaration with the Department ~~of Elections~~ office for the county in which that person is a registered
154 voter.

155 (d) The State Election Commissioner or ~~the Department of Elections for a county~~ Department office for the county
156 in which a person who has filed a Write-in Candidate Declaration is a registered voter shall determine whether ~~a the~~ the person
157 ~~who has filed a Write-in Candidate Declaration~~ is eligible to be a candidate for the office for which ~~that the~~ the person has filed
158 ~~the declaration.~~ Declaration.

159 Section 12. Amend § 3403, Title 15 of the Delaware Code by making deletions as shown by strike through and
160 insertions as shown by underline as follows:

161 § 3403. Forms.

162 The State Election ~~Commissioner~~ Commissioner, in collaboration with the ~~Departments of Elections for the~~
163 ~~counties~~ Department offices, shall promulgate the Write-in Candidate Declaration and the withdrawal form.

164 Section 13. Amend § 3404, Title 15 of the Delaware Code by making deletions as shown by strike through and
165 insertions as shown by underline as follows:

166 § 3404. Write-in candidate lists.

167 Each ~~department of elections~~ Department office shall issue at least 2 copies of the list of declared write-in
168 candidates for each office on a ballot in the county to the election officers at each election district in the county. The
169 election officers shall post 1 copy of the list in a conspicuous location in the polling place.

170 Section 14. Amend § 4502, Title 15 of the Delaware Code by making deletions as shown by strike through and
171 insertions as shown by underline as follows:

172 § 4502. Form and designation of ballots.

173 (a)(1) For each election, the party emblem adopted by each political party and its name shall appear on the ballot
174 with the names of its candidates, arranged in line with the titles of the offices for which they are contesting, along with
175 space for the voter to write in the name of any candidate of that voter's choice, as prescribed ~~in § 5005(b)~~ under § 5005A(b)
176 of this title.

177 (2) In those years in which a President and ~~Vice-President~~ Vice President of the United States are to be
178 ~~elected~~ elected, the ballot ~~shall~~ must be designated "Presidential, ~~Vice-Presidential~~ Vice Presidential, State, ~~County~~
179 County, and District Ballot"; in other ~~years~~ years, the ballot ~~shall~~ must be designated "State, ~~County~~ County, and
180 District Ballot".

181 (3) The names of all candidates of any party ~~shall~~ must be placed under the title and device of such party as
182 designated in the certificate filed with the ~~department of elections by such~~ Department by the party's authorized agent
183 ~~or agents~~ or, if none is designated, under some suitable title or device to be selected by the ~~department of elections.~~
184 Department.

185 (4) When a President and ~~Vice-President~~ Vice President are to be elected, the names of the candidates for
186 those offices ~~shall~~ must be placed at the top of the list of candidates for all offices to be voted upon.

187 (5) The device named and chosen and the lists of candidates of the Democratic Party ~~shall~~ must be placed in
188 the first column on the left-hand side of the ballot, of the Republican Party in the second column, and of any other
189 party, and the space for the voter to write in the name of any candidate of that voter's choice for any office, in such
190 order as the ~~department of elections shall decide.~~ Department decides.

191 (6) The names of unaffiliated candidates ~~shall~~ must appear in alphabetical order, under the heading
192 "Unaffiliated Candidates", after the listing of various political parties.

193 Section 15. Amend § 4503, Title 15 of the Delaware Code by making deletions as shown by strike through and
194 insertions as shown by underline as follows:

195 § 4503. ~~Printing~~ Creating ballots.

196 The Department shall ~~print or cause to be printed~~ create the ballots to be used in the voting ~~machines~~ devices and
197 print or cause to have printed sufficient absentee ballots for any election conducted by the Department under the provisions
198 of this title.

199 Section 16. Amend § 4505, Title 15 of the Delaware Code by making deletions as shown by strike through and
200 insertions as shown by underline as follows:

201 § 4505. Substitution of candidate's name after ~~printing~~ creation of ballots.

202 Whenever a supplemental certificate of nomination is filed naming a substitute candidate, as elsewhere provided in
203 this title, the Department shall promptly provide new ~~ballots or, if necessary, pasters. If the new ballots or pasters are~~
204 ~~received by the Department too late to put them in the voting machines prior to the preparation, sealing and inspection of~~
205 ~~the machines, then the department shall deliver the necessary number of pasters to the inspectors of the appropriate election~~
206 ~~districts, who shall see to it that the pasters are placed and maintained on the voting machines and certificates of election.~~
207 ballots, if there is sufficient time before the election, or take other appropriate measures if there is insufficient time before

209 Section 17. Amend § 4506, Title 15 of the Delaware Code by making deletions as shown by strike through and
210 insertions as shown by underline as follows:

211 § 4506. Tally sheets.

212 ~~The Department shall furnish 2 copies of write-in vote tally sheets for each election district. [Repealed.]~~

213 Section 18. Amend Title 15 of the Delaware Code by transferring § 4516 of Title 15 to Chapter 80 of Title 15,
214 redesignating § 4516 as Section 8045A of Title 15.

215 Section 19. Amend § 4701, Title 15 of the Delaware Code by making deletions as shown by strike through and
216 insertions as shown by underline as follows:

217 § 4701. Appointment; term.

218 ~~(a) The county executive committee of each of the 2 principal political parties shall submit to the Department no~~
219 ~~later than February 1 of each general election year a list containing the names of 8 registered voters for each election district~~
220 ~~in the county. The Department shall appoint all election officers, including clerks, from these lists; provided, however, that~~
221 ~~if the lists are not filed with the Department by February 1 or if the number of names submitted are not sufficient, the~~
222 ~~Department shall select, notwithstanding paragraphs (b)(1) and (2) of this section, some qualified person or persons shown~~
223 ~~on its records to be registered to vote in the election district (or in the absence of such persons, the representative district),~~
224 ~~provided that no more than a bare majority of such persons are members of the same political party.~~

225 ~~(1) The county executive committee of each of the 2 principal political parties may nominate Delaware~~
226 ~~citizens who are full-time students and who will be at least 16 years of age on or before November 1 in the year of a~~
227 ~~general election and who will be less than 18 years of age on or before the day of the general election to serve as clerks~~
228 ~~of election. Such nominations shall be accompanied by an authorization signed by the person's parent or guardian as~~

229 well as the principal of the school the student attends. The authorization shall be on a form promulgated by the State
230 Election Commissioner. The Department may recruit United States citizens who are full-time students and who will be
231 at least 16 years of age on or before November 1, in the year of a general election and who will be less than 18 years of
232 age on or before the day of the general election to serve as clerks of election. Persons recruited by the Department shall
233 present an authorization, on the form promulgated by the State Election Commissioner, to the Department prior to
234 being appointed. Notwithstanding any law or regulation to the contrary, the Department may appoint no more than 2
235 persons under the age of 18 as clerks in any Election District where 2 or fewer voting machines are assigned. In
236 Election Districts where 3 or more voting machines are assigned, 1 person under the age of 18 may be appointed as a
237 clerk for each voting machine assigned. Persons nominated by a political party on or before February 1 in the year of a
238 general election shall be given priority over persons recruited by the Department unless such persons demonstrate that
239 they are unable or unwilling to perform election officer duties. The State Election Commissioner, after consultation and
240 coordination with the Department, shall promulgate the nomination form for the purpose of this subsection no later
241 than January 1, 2004.

242 (2) Notwithstanding any law or regulation to the contrary, the Department may appoint Delaware residents
243 who are registered voters and who are enrolled as at least half-time students in colleges or universities within the
244 respective county as election officers for that county. College or university students recruited by the Department and
245 who will be less than 18 years of age on or before the day of the general election shall present an authorization signed
246 by a faculty member or dean of the school they attend, on the form promulgated by the State Election Commissioner,
247 to the Department prior to being appointed.

248 (b)(1) During the month of April in each general election year, the Department shall appoint for each election
249 district in its county 1 inspector, 2 judges of election, 1 from each of the 2 principal political parties; and 2 clerks of
250 election, 1 from each of the 2 principal political parties, provided that where the election district has fewer than 100 voters
251 of a principal political party, the Department may appoint such party's clerk or clerks of election from a different election
252 district within the same representative district. The terms of the inspectors, judges, and clerks of election shall extend from
253 the day of their appointment to April 1 of the next general election year.

254 (2) Whenever an election district is to be provided more than 1 voting machine, 2 additional clerks, 1 from
255 each principal political party, shall be appointed for each additional voting machine. These additional appointments
256 shall be made in April whenever the number of additional voting machines is known to the department. Subsequent
257 additional appointments shall be made as soon as practicable after the department determines the need for additional
258 voting machines in an election district. [Repealed.]

259 Section 20. Amend § 4702, Title 15 of the Delaware Code by making deletions as shown by strike through and
260 insertions as shown by underline as follows:

261 § 4702. Appointment of ~~additional~~ election officers.

262 The Department may appoint ~~such additional~~ election officers to serve as ~~machine operators, greeters or for other~~
263 ~~purposes deemed necessary to facilitate the operation of polling places.~~ in the polling places.

264 Section 21. Amend § 4902, Title 15 of the Delaware Code by making deletions as shown by strike through and
265 insertions as shown by underline as follows:

266 § 4902. Absence of election officer on election day; notice to ~~department.~~ Department.

267 If on the day of holding an election any election officer authorized by law to serve at the election in any election
268 district ~~shall be~~ is absent from the place of election at 7:00 a.m., the inspector, if present, or, in the absence of the inspector,
269 then any judge who may be present, shall immediately notify the Department office in that inspector's or judge's county of
270 ~~such~~ the absence.

271 Section 22. Amend § 4910, Title 15 of the Delaware Code by making deletions as shown by strike through and
272 insertions as shown by underline as follows:

273 § 4910. Instruction sheets; sample ballots.

274 (a) The State Election Commissioner, in collaboration with the ~~Department,~~ Department offices, shall design a
275 poster or posters that ~~will be~~ is uniform throughout the State. The poster or posters ~~shall~~ must be publicly displayed in each
276 polling place on the day of the election. The poster or posters ~~shall~~ must contain all of the following information:

277 (1) Information stating the date and hours during which the polling place will be ~~open;~~ open.

278 (2) Instructions on how to vote, including how to cast a vote and how to cast a provisional ~~ballot;~~ ballot.

279 (3) A statement on the importance of verifying that the markings on the voting device-printed paper ballot
280 reflect the voter's intended choices, and instructions on what steps to take if the paper ballot does not reflect the voter's
281 actual choices.

282 (3) (4) Instructions for mail-in registrants who are first-time voters under § 303(b) of the Help America Vote
283 Act of 2002 [~~52 U.S.C. § 21083(b);~~ 52 U.S.C. § 21083(b)].

284 (4) (5) General information on voting rights under applicable federal and state laws, including information on
285 the right of an individual to cast a provisional ballot and instructions on how to contact the appropriate officials if these
286 rights are alleged to have been ~~violated;~~ and violated.

287 (5) (6) General information on federal and state laws regarding prohibitions on acts of fraud and
288 misrepresentation.

289 Section 23. Amend § 4912, Title 15 of the Delaware Code by making deletions as shown by strike through and
290 insertions as shown by underline as follows:

291 § 4912. Procedure prior to opening of polls.

292 (a) The election officers of each election district shall ~~attend~~ arrive at the polling place ~~three quarters of an~~ 1 hour
293 before the time set for opening of the polls and shall ~~proceed to arrange the furniture, stationery and voting machine~~

SYNOPSIS

This Act makes necessary changes to Delaware's election laws based on the State's purchase of new voting devices and establishes auditing requirements for the voting devices. The new voting devices will function differently than the existing voting devices and so election law must be updated to conform the law. The new voting devices allow each voter to view a paper ballot with the voter's selections under glass for the voter to approve before pressing the final button to vote.

This Act requires the Department of Elections ("Department") to audit the results of primary, general, and school board elections and establishes the procedure to be used by the Department. This Act also requires the Department to adopt regulations to govern the procedure to be used if an audit reveals a discrepancy.

This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
