## HOUSE OF REPRESENTATIVES 144th GENERAL ASSEMBLY

## HOUSE BILL NO. 347

AN ACT TO AMEND TITLE 11 OF THE DELAWARE CODE RELATING TO THE ESTABLISHMENT OF THE DELAWARE POLICE ACCREDITATION COMMISSION.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1	Section 1. Amend Title 11 of the Delaware Code by adding a new Chapter 97 to read as follows:						
2	"CHAPTER 97. ESTABLISHMENT OF THE DELAWARE POLICE ACCREDITATION COMMISSION						
3	§ 9701. Legislative Intent.						
4	WHEREAS, the safety of all Delawareans is of paramount importance; and						
5	WHEREAS, municipal, county, university, and Delaware River and Bay Authority police departments, in addition						
6	to the Delaware State Police and other State agency police departments, provide a critical role in protecting the lives and						
7	property of the citizens of Delaware; and						
8	WHEREAS, many smaller police departments within the State do not have the resources or manpower to complete						
9	the rigorous standards issued by the Commission on Accreditation of Law Enforcement Agencies, Inc.; and						
10	WHEREAS, the effectiveness of public safety departments would be better served by a statewide accreditation						
11	council and standards achievable by a majority of the departments; and						
12	WHEREAS, the citizens who reside in those jurisdictions would benefit by those departments achieving State						
13	accreditation and maintaining those standards; and						
14	WHEREAS, the establishment of Delaware standards for a State accreditation program requires statewide						
15	coordination and leadership.						
16	§ 9702. Establishment of the Delaware Police Accreditation Commission.						
17	(a)	The Del	aware Police Accreditation Commission (hereinafter 'the DPAC') is hereby created.				
18	(b)	The men	mbers of the DPAC shall be appointed by the Governor. The DPAC shall consist of the following				
19		members:					
20		(1)	The Attorney General;				
21		(2)	The President Pro Tem of the State Senate or designee;				
22		(3)	The Speaker of the House of Representatives or designee;				
23		(4)	The Chairman, Delaware Council on Police Training;				
24		(5)	The Chairman, Delaware Police Chiefs' Council;

43	§ 9703.	Specific	E Functions, Bylaws.			
44		The pur	pose of th	e DPAC shall be to provide policy level direction and draft and implement State level police		
45	accredita	reditation standards for matters related to accreditation. To that end, it shall:				
46		(a)	Develop a	a statewide police accreditation program.		
47		(b)	Develop	standards for the police accreditation program to ensure consistency of police operations		
48			statewide			
49		(c)	Promote	cooperation among state, municipal, university, and Delaware River and Bay Authority police		
50			agencies	in addressing statewide accreditation needs in Delaware.		
51		(d)	Provide 1	recommendations to the Governor and the Delaware General Assembly, when appropriate,		
52			concernin	ng issues related to State level police accreditation standards in Delaware.		
53		(e)	The DPA	C shall operate in accordance with bylaws that it adopts. These bylaws may be amended,		
54			suppleme	ented, or repealed by the DPAC in accordance with the Freedom of Information Act, Chapter		
55			100, Title	29 of the Delaware Code.".
